2. **An order** of interim injunction restraining the 1<sup>st</sup> defendant (whether by himself or by his agents or any other person or authority) from taking further steps which

come in conflict with the Claimant's license over the 1<sup>st</sup> Defendant's professional names, or taking away the Claimant's right to use the said names for the purpose of the said license under the contract, subject-matter of this suit, pending the determination of the Motion of Notice.

**And for Such Further Orders** as this Honourable Court may deem fit and just to make in the circumstance.

**IT IS HEREBY ORDERED AS FOLLOWS:**

- i. That the order sought interim by the Applicant in this Motion supported by the affidavit of urgency are hereby granted as prayed.
- ii. That all parties in this suit are ordered to maintain the status quo pending the hearing of the Motion on Notice already filed in Court yet to be served together with the writ on the Defendants / Respondents accordingly.

Case adjourned to 31<sup>st</sup> May, 2018 for the Motion on Notice.
